#### 11.1607 (j) (3)

Aetna continues to pursue contracts with dental providers where they are available. However, some areas do not have dentist available and/or the dentists available are not interested in reasonable contracts.

### 11.1607 (j) (4)

If a member is unable to locate a participating dentist for their dental needs (including specialty referrals), they should contact Aetna Member Services. Member Services will find a participating dentist for the member within the service area radii (75 miles) or authorize the member to receive covered dental services from a dentist outside the network. The member's out-of-pocket costs will be the same as if they received services from a dentist in the network.

Dental providers and/or members should contact Aetna's member services for assistance finding an available dentist in the network or any time a referral is requested for a non-participating dental provider. If an in-network dentist is not available within 75 miles for covered services, Member Services can authorize dental services from a dentist outside the network. The member's out-of-pocket costs will be the same as if they received services from a dentist in the network.

#### 11.1607 (j) (5)

In the event that a Dental Maintenance Organization (DMO) participating dentist/specialist is not available, the Plan may utilize the Aetna Participating Dental Network (PDN). In addition, the Texas State Board of Dental Examiners mailing list was reviewed for availability of dentists where access standards are not met. The listing of available dentists is included. (A) The dental providers were notified in writing (USPS) and invited to join the network on August 24, 2017. (B) No response to date.

# 11.1607 (j) (6)

Members are instructed to call Aetna Member Services if they cannot find a dentist for their dental needs in the network (within a 75 mile radius). Member services will find a participating dentist for the member or authorize the member to obtain services outside the network. The member's out-of-pocket costs will be the same as if they received services innetwork.

When the member contacts Aetna for assistance in arranging dental services by a non-participating provider and the Plan authorizes care for these covered services, then the member does not need to file a request for reimbursement.

## 11.1607 (j) (7)

Aetna continues to pursue contracts with dental providers where they are available. In order to improve the network access plan, Aetna takes the following steps -

Annually, provider solicitation notices are published in publications around the state inviting providers to join the network.

The Texas State Board of Dental Examiners mailing list is reviewed for availability of providers where access standards are not met. The available dental providers are notified and invited to join the network.

### 11.1607 (j) (8)

In the event that a Dental Maintenance Organization (DMO) participating dentist/specialist is not available, the Plan may utilize the Aetna Participating Dental Network (PDN). The fees for the participating PDN dental providers have been negotiated in advance.
