

## OVERVIEW

Each health benefit EPBP or PPBP must include a delivery network that is adequate and complies with Insurance Code §1301. All covered services that are offered by an EPBP or PPBP must be sufficient in number and location to be readily available and accessible within the service area to all enrollees.

When contracted providers are not available within the TDI mileage access and/or availability standards outlined in Title 28 Texas Administrative Code Section 3.3704, **(TX) Aetna Whole Health - Rio Grande Valley - Open Access Elect Choice/Open Access Aetna Select** provides for in-network benefit coverage and has procedures that the EPBP/PPBP will use to assist enrollees in obtaining medically necessary services when no network physician or provider is available, including procedures to coordinate care.
